#### RP Grand COOKIE POLICY Version <u>No. 1</u> of <u>01.12.2023</u>

### 1. More info about cookies

1.1 Cookies are small text files, temporarily placed on your computer or other device connected to the Interconnected Networks. Cookies are used to increase the effectiveness of the https://rpgrand.com website, as well as to help obtain information about users: from which country users visited the site, their number, what pages they visited, what were their advertising preferences.

# 2. RP Grand policy regarding cookies

2.1. Administration of the site <u>https://rpgrand.com</u> (hereinafter - the Administration of the site) collects, analyzes and stores cookies collected with the consent of users of the site.

2.2. The website Administration acts on the principles of legality, impartiality and transparency in all dealings with users' personal data (including that obtained through the use of cookies), which is expressly stated in paragraph A, part 1 of article 5 of the REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter General Data Protection Regulation).

2.3 If the user refuses to use cookies, some pages of the site may not work properly, so that access to them can be closed unilaterally until the user's consent to their use is obtained.

# 3. User data to be collected:

3.1 We use all or some of the following categories of cookies on our website:

- a. IP address;
- b. Information about the browser used;
- c. Time of visiting the site;
- d. Statistics of the time spent on the site;
- e. Visited sections of the site;

f. What platform for accessing the Interconnected Networks did you use? (Personal computer, phone, tablet);

g. Cookie for user authentication, which allows not to go through the process of authorization each time again.

# 4. Security of user data

4.1 Administration of https://rpgrand.com timely takes technical and organizational measures for an effective application of the principles aimed at PROTECTION of user data.

4.2 Taking into account the state of science and technology, the volume, specificity and purpose of processing, as well as the probability of risks and dangers to the rights and freedoms of individuals, based on the requirements of the General Data Protection Regulation, the Administration of https://rpgrand.com applies the following technical and organizational measures to maintain a level of security commensurate with the risks
